Sealed bids, clearly marked on the outer envelope with “**Tender Description and Reference Number**” must be deposited in the Tender Box at address at 6(c) **below at or before 10.00 a.m. (local time) on Tuesday 12th April 2022**. All bids must be accompanied by a **Duly Signed Bid Securing Declaration Form**. Late Bids will be rejected and returned to the bidder unopened.
