The Electricity Supply Corporation of Malawi Limited has planned for implementation of a turnkey project including financing for **Design, Supply, Construction and Commissioning of Nkhotakota - Chinyama 66kV Steel Power Transmission Line and Associated Substation Works including Financing on Engineering-Procurement-Construction Plus Financing (EPC+F) arrangement.** Interested bidders are further advised that there are three components in the procurement process thus Technical Proposal, Financial Proposal and Detailed Financing Scheme/Proposal which shall state the detailed terms and conditions of the financing so proposed.
